


SDG Goal 10 calls for reducing inequalities in income as well as those based on age, sex, disability, race, ethnicity, origin, religion or economic or other status within a country. The Goal also addresses inequalities among countries, including those related to representation, migration and development assistance whereas around the globe, the disparities remain very alarming .

Communities Discriminated on Work and Descent (CDWD) numbering more than 260 million people across the world, are among the most marginalized and excluded peoples, many of whom are persons living in conditions of slavery often tied to descent, similarly LGBTI populations are still criminalized and experience stigma, discrimination, violence, and other human rights violations due to their sexual orientation, gender identity, gender expression, and sex characteristics (SOGIESC).

Within the confines of the shackles placed upon us, lies the potential of those whose potential remains disproportionate to please the purely imaginary cemented structures and hierarchies of “normality”. A vision of a world that allows people to be equal and leave no One Behind , express their true potential is needed to achieve SDG 10 and address gaps in global governance for the Summit of the Future

Session description

While the session aims to give space to discussions around civic space writ-large, the main focus will lie on discussions as understood in the second definition. This allows to connect activists and CSO representatives from very diverse contexts around the world. The interaction with UN bodies or other global governance mechanisms can still take very different forms, depending on whether we talk about the situation of inclusion into UN mechanisms in New York, at UN and other (AU, EU, AL, ASEAN,) regional offices, or at national level. The session thus also aims to highlight the gaps or differences of inclusivity within these different regions and to create a shared understanding within the audience about the achievements and challenges to civil society and civic space across those regions.

The session will start with a short keynote speech from): Aish Machani from ISWE Foundation (tbc), who will provide a short update on their experiences at the UN Civil Society Conference in Nairobi. Following that, there will be a world cafe on the following themes:

Session description

As world leaders convene at the Summit of the Future, this moment provides a crucial opportunity to reassess and reinvigorate commitments towards SDG 16 and its pivotal role in fostering peaceful, just, and inclusive societies globally because the global landscape remains fraught with challenging multidimensional crises. The aftermath of the COVID-19 pandemic, compounded by the climate crisis and escalating food insecurity, alongside rising geopolitical tensions, is placing unprecedented pressure on international security and multilateral cooperation. Protracted and new conflicts, rise in coups d'états and tensions around the world, from Armenia-Azerbaijan, China-US, Ethiopia, Haiti, Myanmar, Israel-Palestine, Sudan, The Sahel, Russia-Ukraine, a potential wider Middle East war, and backsliding democracy in western countries, amongst others, underscore the pressing need for transformative action.

The session will cover the following main components:

- An overview of the current state of global peace and security, being undermined by increasing conflicts and war across regions;
- A brief review of the Pact of the Future's response to current peace and security crises across the globe by United Nations Member States, but also the contributions from civil society colleagues to address these challenges;
- Identify opportunities and strategy for collective advocacy and mobilization by providing successful cases for peacebuilding at the global, regional and country levels.

The global crises of conflict, climate change, closing of civil society space and humanitarian catastrophe are reshaping the landscape of our political, social, and economic systems. In this context, young people, together with older generations, are uniquely positioned to question the status quo, innovate solutions, collaborate and drive transformative change. However, for these efforts to be effective, they must be supported by inclusive multilateralism that truly engages all ages and all generations.

Session Objectives:

- Highlight the critical role of children, adolescents, youth, adults and older persons in shaping the future of multilateralism, especially in ensuring that the global frameworks are age informed and age-inclusive
- Explore the benefits of intergenerational engagement in addressing global challenges and ageism, drawing on the unique strengths of each generation, and highlight success models of such engagement at national, regional and global level and inside the UN
- Facilitate ongoing dialogue between youth and older generations to identify strategies for fostering greater collaboration and innovation in lead-up to and within the various processes coming up in 2025, including the World Social Summit and the Beijing +30
- Develop actionable recommendations for enhancing youth and older person participation in multilateral institutions, ensuring that their contributions and perspectives are integrated into the implementation of the Pact for the Future and other upcoming processes in 2025
